



THE ROLE OF THE VILLAGE GOVERNMENT IN SUPPORTING CORN FARMING COMMUNITY INCOME

Abstract

This research was conducted at the office of Lala Village of Namlea District. The village government's role in community development in the Village Lala Namlea District of Buru district is significant to support the conditions of this Village because most of the people in this Village have subsistence corn farmers to empower corn plants. The aims of this research were to determine and analyze the extent of countryside government and factors that encourage and inhibit the role of countryside government in supporting the income of corn farmers at Lala village, Namlea sub-district of Buru districts. The results showed that the village government, Lala plays a vital role in determining the appropriate steps to increase the incomes of farmers' corn or empower the people in the Village of the District La la Namlea.

Abstrak

INTRODUCTION

Government village as end spear in system government area will relate and touch directly with the public. Because of that, the government area's system and maintenance mechanism, the Government area, was very supported and determined by the Village Government and Body Deliberation Village (BPD) as part of the government Area.

Structure institutions and working mechanisms in all levels of government, especially the village government, must be directed to create a government sensitive to development and change in society.

In maintenance, the government must see as a multidimensional process that covers various changes fundamental to society's structure, public attitudes, and national

institutions. Besides permanent chase acceleration enhancement economy, public alleviation poverty.

The government's role in analyzing the social economy is to create a level economy free from pressure and competition toward independence. Destination economy, which becomes a base for enduring in era decentralization and wrong one challenge is empowerment public going to stability economy from various level when stability economy guarantees an economic strength for that which particular access source economy which bigger. The fundamental strength in answering this is how the public economy bottom can increase. From the condition here, empowering the public poor is a method for noticing aspect productive, with no neglect of specification expertise so that the input distribute economic enterprise for small communities will succeed. We understand that the government's role is much needed to solve various problems like poverty, social gap, unemployment, etc. However, understanding which thereby cannot be left so just without existence critics nor control to input because on principle presence government could be assumed as one- the only method for could solve the problem can turn around the fact, like existence gapsocial economy.

They were starting from the problem the involvement active and seriousness from local government good government center, government area, districts nor government village. The government must also look at every policy which will be implemented or held, good that in the form of regulation legislation, nor through regulation area which will be issued or run. Whereas the public alone will be positioned to judge whether policies could, say as the wrong one, solve a problem or, on the contrary, could cause new problems again in government.

Lala village is still doing good development from side infrastructure and superstructure and fixesservice public which

still left behind as well as give contribution thought and power in programs government Village. The condition required for showing the height level growth economy success held by the village government is existence enhancement income economy Public so that impact on enhancement level well-being Public.

Problems faced in the Lala village Subdistrict Namlea Regency Buru is the role of the village government in ~~empowering~~ the public not yet held by maximum. This look to empower the corn farming community. Even though corn is a leading commodity, farmers are worthy of upgrading in this Village because the region's topography village is very suitable for the type of plant corn.

The role of the government village in empowering public farmer corn needs attention as a program agropolitan to increase well-being Public, mainly because not yet looked. The government hasn't tried empowerment good in counseling system method planting corn which good, provision seeds fertilizer and Pesticide nor arrange marketing corn which can empower corn farmers.

Role of government village in empowerment Public in Lala Village Subdistrict Namlea Buru District, essential for support the village condition this because most of the people in This Village has a livelihood as farmer corn, so that allow in activity empowerment plant corn.

Care plant corn ~~was~~ done by the community naturally and with no fertilizer and optimal Pesticide. Thing this because of the difficulty getting fertilizer and Pesticides. Part fertilizer and Pesticide for sale also in shops closest but with the price too expensive. This has an impact on the corn harvest and is not suitable with hope.

Based on the description problem, the optimal Village Government's required effort to empower Public farmer corn could enhance the well-being of the Public in Lala village Subdistrict Namlea Regency Buru.

Based on the background above, the author intends to do the study with the title "Role of village government in supporting the income of public corn farmer in Lala village Subdistrict Namlea Buru Regency." Becomes the focus problem in the study. This is the role of the Government Village in supporting the income of Public Farmer Corn in the Lala village Subdistrict of Namlea Regency Buru.

RESEARCH METHOD

Approach and Type Study

The approach used is phenomenological. According to Moleong (2001:1), "Approach phenomenological in study qualitative attempted for understand meaning incident and relation to ordinary people in a situation-specific. Used qualitative approach because of the suitability Among characteristics and suitable characteristics, including: (1) instrument main is Government Village, (2) character descriptive, (3) work field, (4) holistic. The type of study used is qualitative with an approach this character interpretive for understanding meaning and interpretation saved in intention the culprit. Design measurement, analysis, and report study based on destination study which emphasized on meaning role Head Village in support income economy Public as well as successful development.

Location Study

Study this held in Lala village Subdistrict Namlea Regency Buru and planned allocation time in this study for 3 (three) months. Since implementation studies Introduction until with complete the mentoring process in arranges report results study.

Source Data

To gather data, the researcher set several sourcedata as follows:

Primary data is direct information from Head Village, Chairman BPD, Chairman LPM, figure Public, and figure religion in the Lala Village area Subdistrict Namlea.

Source secondary is source data obtained

from library research, documentation, literature, or reference concerning the problem studied in the study.

Collection Procedures and Analysis Data

Data recording in this research involves interviews, documentary studies, field observations, and observations. The data analysis technique used in the study is qualitative analysis; namely, the process analysis starts with the study and study of actual data obtained from various related sources.

RESULTS AND DISCUSSION

Location Overview Study

Lala Village is the wrong Village from 13 Village in Subdistrict Namlea Regency Buru. The Village has stood up since the end of the Year 2019 following Regulation Area Regency Buru Number: 06 the Year 1998 About Formation Village. Lala village as expansion combined from Village Parungi and Village Motoduto Subdistrict Namlea.

A large region of Lala village is 1,675,075 Ha Village Area Lala cover on area soil rice fields broad 10 Ha, land corn plantation area of 1,565,075 Ha and other wide 100 Ha. Settlement Public spread on land rice fields and corn plantations, the community's main livelihood of the Lala Village Subdistrict Boliohuto Regency Buru.

Lala Village Area's geographical location is 0°41.29° Latitude North and 122°37,21 longitude east. View from topography height, the area of Lala Village is 36 m above sea level with an average rainfall is 20 mm/year, and the average temperature per year is 30° with an average humidity average of 70% per year. Village Area La la Subdistrict Namlea Regency Buru, located on part west Regency Buru with adjacent north border with Village Iloheluma, Adjacent South bordering Suka Damai Village, adjacent East border with Village Parungi and adjacent West border with Motoduto Village.

District Lala Village Namlea, Buru

Regency, administrative in charge of 2 hamlets: hamlet Pone and hamlet excitement. Amount population in Lala village Namlea District, Regency Buru year 2015 amount 537 souls that is population man amount 273 souls and population woman amount 264souls. While the number of Heads Family as much 150 KK. Eye livelihood population part big is farmer corn; the rest are farmers, entrepreneurs, laborer farmer, factory sugar, laborer coconut flour mills, and civil servants.

DISCUSSION

This study was held in Lala Village, Namlea District. Of course, have programs Village which aim to increase economic income for people or, say, other advance Village and increase income for its people. In the process of data collection in this study, through studies literature researcher also Does observation and interviews (Interviews) with several informants. Interview (Interview) to informant done so that the author gets valid information about the problem researched from the informant who has competence regarding the government's role in improving the economic income community in Lala Village.

The first informant determined in the study is the Head of Lala Village, the head of BPD Lala Village, and ten people in the community. However, in line with studies and needs information writer, an informant in the study this increase from previously, informant this is parties related in enhancement economy village community itself. In carrying out interviews (Interviews) as an instrument, the researcher uses guidelines for Interviews, which are arranged based on a focused study set previously. This interview guide consists of general questions and questions which are nature detailed. This was conducted so that the researcher could produce accurate data and complete the information needed in this study.

Role of Government Village in Boost

Farmer Community Income Corn

Role Government in increase income farmer corn in Lala Village, District Namlea Regency Buru discussed through indicators namely the role in the socialization of procedures planting corn, role in provision seeds, fertilizer and Pesticide and role in help marketing yields.

1. Role Government in socialization system method planting corn

Role of Lala village government Subdistrict, Namlea Regency of Buru in socialization system method planting corn conducted with method socialization about types seeds corn so that Public farmer corn could choose type seeds good corn for planting, Beside that, it also conducted socialization special techniques for planting corn and maintenance plant corn which good for Public farmer corn.

Socialization activities are carried out four times a year, at the beginning of planting season, at the Village Office Lala Subdistrict Namlea Regency Buru. Implementation socialization is held by apparatus Village Government starting from the Head Village, Secretary Village, and para Head Affairs Village and work same with hall agriculture local.

Process implementation socialization started with sending a letter Application to the Agricultural Center local and, based on the letter's reply, willingness extension worker agriculture apparatus. Government Village contact para head village for tell to the farming community. On implementation socialization and whole activity borne by apparatus Government Village whereas hall agriculture local only hold energy extension officer.

Based on the description, the role of Government Lala Village in empowering the farming community has been implemented through program performance Village as a form of concern for the community farmer corn in Village Lala Subdistrict Namlea Regency Buru. As a result Interview with the Head of Lala Village Subdistrict

Namlea Regency Buru (HK, 40 Year) explained as follows:

"As Head Village I very responsible answer in role to support income Public farmer corn in Village La la. Role Government Village in socialization started with election land which good for corn, then socialization selection of suitable maize seeds. Although the power extension worker we bring from Hall Agriculture local, implementation fully set by apparatus Government Village starts from contacting the community, preparing administration, and even stage consumption. However, activity the until the moment this still programmed in 4 times in a year Criteria for land, seeds, and fertilizer as well as method care all given in socialization by extension worker agriculture" (Results Interview, 15th of September 2020)

Based on the results Interview on researcher think that the Government of Lala Village Subdistrict Namlea Regency Buru has been held with good, although in the range of one time season plant. Head Village feels responsible for improving the economy. Public farmer corn so that implementation socialization conducted with method election land which good for corn, then socialization election seeds corn which in accordance by power extension worker from hall local agriculture.

For smoothness activity socialization system method planting corn to the community farmer corn in Lala Village, District Namlea, beside the Village Chief, apparatus Government Village other give a contribution in helping Head Village. The thing this results from the Interview with Secretary Village La la, Subdistrict Namlea Regency Buru (LH, 25 years) explains as follows:

"Although activity socialization is held direct by power extension worker agriculture, the role we in Village brings power extension worker the. As secretary of the Village role, I especially prepare a letter

application to Service Farmer local, then check the availability of agricultural extension workers. I make a letter for Head Hamlet to be passed on orally nor written to Public farmers so that they present in activity counseling. In the side that on program socialization I on duty prepare the whole program as well as determine the place implementation socialization" (Results Interview, 15 September 2020)

Based on the results Interview look Secretary Village La la Subdistrict Namlea Regency Buru, one of the Village apparatuses, has played a significant role in the activity socialization method of corn planting. Secretary Role Village includes preparing letter applications, checking the willingness of extension workers, making a letter for Head hamlet, preparing the whole program, and determining the place implementation socialization.

Implementation of activities socialization carried out followed by part big Public corn farmers who are more than 70%. If there is a society farmer corn, who is not present, then the head of the hamlet is tasked with providing directions for the next meetings. The enthusiastic public can also be seen in the number of public who ask to para extension worker field about the material discussed.

2. Role of Government in the provision of seeds, fertilizer, and Pesticide

The role of Lala village government Subdistrict Namlea Regency Buru in the provision of seeds, fertilizer, and pesticides, cannot be implemented by the village government. This can be seen from no seeds, fertilizers, or pesticides in this Village. Part big Public farmer corn must buy seeds, fertilizer nor Pesticide must to City Buru which is about 60. Away kilo meters from Village La la.

Besides that, there is Public farmer corn who are forced to buy seeds, corn, fertilizer, and Pesticide from stalls owned by communities in neighboring villages, such as Village Sidomulyo and Village

Sidodadi, with a relative price expensive from prices determined government. Special fertilizer subsidy in Village La la is still remarkably insufficient, and many subsidized fertilizers are only destined for farmers' rice fields. This means the government's attention to providing seeds, fertilizer and pesticides have not yet been noticed with good. State the, when confirmed to the village head La la Subdistrict Namlea Regency Buru (HK, 40 Year) explained as follows:

"Weighty heart we say that role in the supply of corn seeds, fertilizers and Pesticide not yet could we do. We, of course, enter sense because the role needs capital, which covers problem provision and procurement of goods. Problem this already once expressed by the farming community corn on us but until then We haven't coordinated yet with superior because bustle looks after activity other. Several times then we have prepared a proposal and beg hint to superior (Camat,) however until the moment this activity the has not been realized" (Result Interview, 19 September 2020).

Based on the interview results, it could be concluded that the role of Lala village Government Subdistrict Boliohuto Regency Buru in providing corn seeds, fertilizer, and pesticides has not yet been held. Head Village and other village government officials have not provisioned seeds for corn, fertilizer, and pesticides, which could make it easy for public farmers to corn. State this clear result in Public farmer corn meet difficulty in looking for good corn seeds for planting. This situation is in line with what was put forward by a community of corn farmers from Pone Hamlet (JR, 38 years) as follows:

"It is true. In this Village, we are challenged to find seeds of good corn. Even though there are only stalls in Village about price, which is very expensive because traders look for high profit, in the

city too, there is (City of Buru, researcher) but we must rent a car to go home. This results in the treatment of the corn that we plant can't well. Especially if there is a corn disease season, forced we have to be patient because it's expensive pesticides to spray disease corn crop and in the end harvest corn no succeed in accordance which we expect" (Results Interview, 21 September 2020)

Based on the interview results, it could be concluded that Public farmer corn in Village La Subdistrict Namlea Regency Buru is having trouble finding good corn seeds. There are also corn seeds, fertilizers, and pesticides at stalls in Village about, but they are costly. Part Public corn farmers are forced to rent a car to City Bto to buy corn seeds, fertilizers, and pesticides, and the cost of planting cruising is expensive.

Role in Help Marketing Results Harvest

One of the Government Village's essential roles is empowering Public farmer corn and helping marketing results harvest corn. In Lala Village Subdistrict Namlea Regency Buru, the role in helping marketing results from corn could not yet be held with good. In this case, the Village Government could not yet strive so that Farmers don't just sell their products in the harvest.

Based on observations, in the subdistrict, there are stalls, which belong to businessman trading, so that price is low, Rp. 2000,- for corn wet and Rp 2500,- yang dry. in fact, no in accordance determined by Provincial Government, namely Rp. 2700,- for wet corn and Rp. 3,000,- dry. Even some farmers already tie contracts with para intermediaries who take more profit by giving money before crop corn is harvested. Thing this resulted in the price of corn being meager.

Government of Lala Village Subdistrict Boliohuto Regency Buru based on confirmation confess problem. Based on the results of interviews with Head Village

Lala Subdistrict Namlea Regency Buru (HK, 40 Year), explained as follows:

"Of course, Correct we apparatus The Village has not been able to control the price of corn for sale farmer. Thing this because most of the farmers have subscribed to merchants. Para traders who have provided transport trucks arrived at the corn plantations and they buy inexpensive corn, but for sale warehouses in City, Buru is up with prices high. An effort which has we do notify the normal price determined by government area to farmers, but because farmers difficulty transport results harvest until to warehouse Buru forced for sale to trader and middleman. We have no funds for help buy corn farmers and provide trucks cowardly because of limited funds" (Results Interview, 21 September 2020)

The interview results show that there is not yet a role of Government in Village La la districts Namlea in helping maintain crops of corn. Government quibbles that role the need Support fund because the government must accommodate results harvest corn farmers are then transported to warehouses warehouse in City Buru. Effort The Government informs the specified regular corn price by Government area to farmer corn but thing this not capable controlling the price of corn in the Village the. Attitude apparatus Government about problem marketing community corn has not been done. The thing that looks at attitude apparatus, which no one strives to ask help from the government Province for help marketing results in harvest corn because if this problem left will impact on loss of motivation. The public in plant corn an eye livelihood.

Role of Government Village in Empowering Public Farmer Corn in Lala Village.

The Village Government La la Subdistrict Namlea in empowering Public farmer corn could be seen from some aspects, i.e., increasing income Public

farmer corn, increased results harvest corn, and increasing demand family economy. Based on the results study on Village Government's general role in increasing the income economy, Public farmer corn has not yet given optimal results. State the will be explained following aspects empowerment as follows:

Income increases corn farming community

Lack of upgrade income economy Public farmers in Lala Village caused by some Thing, as Interview with a farmer from Pone Hamlet, namely (SI, 45 years old) explained as follows:

"Land empty in Village this of course still many which could be processed but the public's interest in process land agriculture Becomes maize land is still very less. This is caused by the more difficulty getting corn seeds which is good. On the side that the difficulty gets fertilizer and Pesticide in care corn make Public more good plant other crops such as secondary crops, vegetables easier vegetables and tomatoes the treatment" (Results Interview, 21 September 2020).

Based on the interview results, there could be no increase in Public farmer corn caused by the difficulty of getting good corn seeds. Difficulty faced farmer corn the make farmer other more good plants other which easier for planted and treated.

The reason was other than not enough increase amount farmer corn in Village Lala. Subdistrict Namlea Regency Buru due to lack of government role in giving motivation for farmer corn especially provision seeds plant corn, fertilizer, and pesticides so that the farmers not motivated in cultivating corn farms. The Chairman of the Village BPD Lala Subdistrict Namlea Regency Buru (SN, 42 Years) explained as follows:

"Less increase the number the income of farmers in this Village is not just caused by difficulty search for seeds, fertilizers, and pesticides, but part because not

enough interest family farmer to agriculture. Many farmers in this Village have a child who is currently studying, but their son is not interested in agriculture because he considers school unsuitable. So many children- child farmer Becomes employee and employee in the company like Factory Sugar which is the distance around 18 kilometers, and also factory flour coconut which the distance 2 kilometers from this Village; it has even been opened again company coconut palm which is in a neighboring sub-district, namely in districts Wonosari" (Results Interview, 23 September 2020).

Based on the results Interview, there is not enough income increase for farmers in Village Lala Subdistrict Namlea Regency Buru. Besides being caused by difficulties looking for seeds, fertilizer, and pesticides, part is also caused by low interest in family farmers in agriculture. Part children farmer Becomes employee and employee in company- company.

Area of Corn Field

Based on data collected, land farmer corn in Village Lala Subdistrict Namlea Regency Buru Year 2015 that is hamlet Pone 55 hectare, and hamlet Pone as much 57.5 hectares (Office Village Lala). Based on these data, the Interview with Head Village Lala Subdistrict Namlea Regency Buru (HK, 40 Year) explained as follows:

"Reduced land agriculture corn no just caused by lack of role apparatus Government Village, but because many land agriculture corns converted for plant other, for example, made land rice fields, planted vegetables and palawija. Besides, there is a corn field on edge Street made settlement by inhabitants and for sale to party others It has become the place to set up stalls and shop even now, there are residents who have sold their farm to companies like coconut palm. (Results Interview, 21 September 2020)

Based on the interview results, it looks like the central lack of increase in area

corn plantations is caused by the conversion of corn land for plants other like palawija and vegetables. Besides, there is corn on the edge of streets used as settlements by residents and other business areas.

Harvest Corn Results

Farmers' target end of the corn farming activity is to harvest corn in Village Lala's corn harvest yet experience enhancement every year. This is caused by a lack of reasonable care for corn plants and the types of land in this Village that are not cultivated again with corn plants, reducing the results of harvesting corn. Part farmers to do care plant corn manually without fertilizer or pesticides. Results harvest plant corn in Village Lala in 2011 as many as 8 tons, in 2012 as many as 13 tons and in 2013 as much 12 tons (Office Village Lala/data Results Harvest 2019).

This increase in agricultural yield is an opportunity for the community and apparatus Government Village Lala Subdistrict Namlea Regency Buru to increase the harvest of corn. Plant corn could be a source of livelihood for farmers, which needs support and the government's role to enhance the public economy.

Economic Needs Family

One indicator of progress in public is an increased need for economic families. Village Lala Subdistrict Namlea Regency Buru, on the public, which does not yet show enhancement, needs an optimal economy. The thing looks on interest buys shallow family. Several indicators look between still low interest buy to vehicle motorized and goods electronics on each family.

Based on the results Interview with Public Village, Lala (YES, 45 Year) explained that:

"In this Village, if the harvested corn many used by the farmer for sending to school his son. Part also there is which buy object electronics and vehicle motorized, but only part small. If harvest

corn succeeds with good, so we Use results for the buy needs economy, which is more critical (Results Interview, 19 September 2020)

Based on the results of the Interview in on could be concluded that the results of corn farmers' harvest are not enough needs and increase the economy for the public. The better the yield increases, also need economy family. Good yields increase family economic needs such as buying objects and electronics like television, videos, and motorized vehicles. Only part small Public farmer corn in Village Lala doesn't have a vehicle yet, motorcycle wheels two and four.

Factor Supporter and Role Inhibitor Government Village in Boost Economy Farming Society

Every activity has a factor supporter and inhibitor. Thereby also with role Government in increase income farmer corn in Village La la Subdistrict Namlea Regency Buru. By detail factor supporter and blocker the will be outlined as follows:

Role Government in Socialization System Method Planting Corn

From the results study obtained that the factors that support the role of Government Village La la Subdistrict Namlea Regency, Buru in the socialization of procedures planting corn as follows: Factor Supporter that is connected and work same which good Among Extension and apparatus Government Village, Enthusiastic Public farmer corn in following socialization which in doing it as well as building ready and supportive meeting activity. Factor Inhibitor is the lack of coordination with government officials to Service Extension Agriculture, the public, which no realization and apathy towards outreach activities, as well as no existing means and infrastructure.

Role of Government in the provision of seeds, Fertilizer and Pesticide

From research results, it was found that the supporting factors are gift capital

from Government areas to Government Villages in providing tools, and materials, Corn farmer community awareness in setting up Cooperative everything effort as well as Support party private in building Shop and Stall Saprodi in the village environment. Factor Inhibitor that is lack of awareness Public in use care corn because it's still manual, no there is an effort in setting up cooperative provision seeds, fertilizer and Pesticide as well as no there is Support party to three in providing facilities and infrastructure for the provision of tools and agricultural materials.

Role Government in Help Marketing Results Harvest

The results study obtained that factor Supporter that is aware of farmers' not selling produce harvest to para middleman; concern Government Province for pick up direct results harvest in the location field. Factor Barriers are people who sell results harvest to intermediaries and no existence concern Government Province for picking up direct results harvest at the farm location.

CONCLUSION

Based on the results of research and discussion on could be concluded that the role of Government Village in empowering Public farmer corn in Village La la Subdistrict Namlea, Regency Buru not yet held optimal. Several roles have been held with good, but others have not yet been done expectedly. Role Government Village La la which has in does it namely:

- Bring extension worker agriculture with To do socialization system method planting corn. However, there are still aspects that need to be noticed between need range time implementation socialization and form socialization in form garden pilot conducted by apparatus Village government.
- Role Government in the supply of

corn seeds, fertilizers, and Pesticides not yet held. Village government yet strive to provide seeds, fertilizer, and Pesticide so that part giant Public farmer corn must buy seeds, fertilizer, and Pesticide must apply to City Buru.

- Role Government in Help Marketing Results Harvest is also not yet held with good. In thing, this Government Village not yet could strive so that farmer no any sells results the harvest. Role government Village La la districts Namlea in help marketing results harvest corn not yet looked. Government quibbles that role that requires financial support, which is quite significant because the government must accommodate the results harvest of cornfarmers.
